Alexander BAUMGARTEN is Reader at *Babes Bolyai* University of Cluj, and former Vice-President of the National Council of Research. Specialized in Antiquity and Medieval Philosophy, Alexander Baumgarten is the author of *The Principle of Heavens*" *The Eternity of the World and the Unity of Intellect within the Philosophy of the 13<sup>th</sup> Century* (Dacia, Cluj, 2002, and Humanitas, Bucharest, 2008) and of numerous articles on antique and medieval philosophy. He has translated several works from Greek into Romanian, and he is the Editor-in-Chief of the "Classical Sources" Series at Humanitas, the "Medieval Library" Series at Polirom, the "Cogito" and "Mediaeval Philosophy" Series at Univers Enciclopedic. He is also Editor of *Chora-Revue des Etudes Anciennes et Medievales*.and a member of the Advisory Board of "Neoplatonism" Series at Zeta Books Press and of other professional associations (among which The International Society *St. Thomas Aquinas, Societé Internationale pour l'Etude de la Philosophie Medievale*).

Ivan CALLUS is Associate Professor and Head of the Department of English at the University of Malta, where he teaches courses in contemporary narrative and literary theory. He is co-editor, with Stefan Herbrechter, of Discipline and Practice: The (*Ir*)resistibility ofTheory (Bucknell University Press. 2004). Theory/Culture/Criticism (Rodopi, 2004), Cy-Borges: Memories of Posthumanism in the Work of Jorge Luis Borges (Bucknell University Press, 2009), Posthumanist Shakespeares (Palgrave Macmillan, 2012) and, with James Corby and Gloria Lauri-Lucente, of Style in Theory: Between Literature and Philosophy (Bloomsbury Academic, 2013). He is the author of papers on poststructuralism and contemporary fiction and is completing a manuscript on the anagram notebooks of Ferdinand de Saussure. His most recent research is on reclusiveness and posthumanist politics.

**Dragoş CIUPARU** is Professor at UPG Ploieşti. In 1999 he obtained his doctoral degree at University Paris 7 – *Denis Diderot*, and in 2006 he was Visiting Professor at Yale University. Winner of several international grants, he is a member of several Professional Bodies (such as Sigma Xi member, the North American Catalysis Society, the American Chemical Society, AIChE). He was the president of ANCS (The National Authority for Scientific Research) between 2010 and 2012, where he was in charge of both national funds and EU structural funds, programmes that stimulated the contact between public and private stakeholders, attempting to stem the flow of promising young researchers leaving the country.

**Petre T. FRANGOPOL** is former Professor of Biophysics at "Alexandru Ioan Cuza" University of Iaşi and Honorary Member of the Romanian Academy. He worked as the Head of Laboratory at the Institute of Atomic Physics, Bucharest (1957-1993) and he was Senior Research Scientist. He was Post-Doctoral Fellow of the National Research Council, Ottawa, Ontario, Canada and the beneficiary of a NASA contract at "George Washington" University, Washington. D. C. and the *Dozentenstipendium* at Humboldt Foundation. He was Scientific Counsellor of the President of The National Research Council (2002-2010) and Advisor of the Vice-President of the Romanian Academy

(1995 -1998). He is a member of the Distinguished Reviewers Board of the leading international scientific journals *Scientometrics* and *Journal of the Radioanalytical and Nuclear Chemistry* (Springer) and the editor in chief of *Revista de Politica Știintei și Scientometrie*. He is the author of over 200 scientific papers in leading international journals, as well as the author of *Mediocritate și excelență* – o radiografie a științei și învățământului din România (four volumes).

**Daniel FUNERIU** is the former Romanian Minister of Education (2009 – 2012). He holds a PhD from Louis Pasteur University in Strasbourg, under the supervision of Nobel Prize winner, Jean Marie Lehn. After several years in research (at Scripps Research Institute, La Jolla, California, at National Institute of Advanced Industrial Science and Engineering, AIST, Amagasaki, Japan), in 2006 he won the highest amount ever granted under the *Marie Curie Excellence Grant* and formed a research team at the Technical University of Munich. His major contribution to Romanian education was Law no. 1/2011.

**Ioana GALLERON** is Reader of French in Université Bretagne-Sud (France). She completed a PhD in French Language and Literature at the Université Paris IV (Sorbonne), after obtaining a Bachelor's degree in Romania and a MA in École Normale Supérieure (Paris). She is a member of the research laboratory "Héritage et constructions dans le texte et l'image" (EA 4246), where she works primarily on the topic "Politics and literature". Since 2000, she has been researching the "goulag literature", field in which she published several studies, among which «Document et antiutopie. La littérature des anciens détenus politiques roumains», in *The Conscience of Humankind. Literature and Traumatic Experiencies* (Amsterdam – Atlanta, Rodopi, TEXTET, 2000), «Désinformation et confiance. *Le Montage* de Vladimir Volkoff», in *Cahiers Maubert*, (2008). She has co-edited (with Isabelle Durand Le Guern) *Roman et politique. Que peut la littérature*? (Rennes, PUR, 2010).

**Stefan HERBRECHTER** is Reader in Cultural Theory (Department of Media, School of Art and Design, Coventry University, UK). He studied English and French at Heidelberg University, and English literature and Critical and Cultural Theory at Cardiff University. He is series editor of Critical Posthumanisms (Rodopi) and author and editor of a number of books on a variety of aspects in English and comparative literature, critical & cultural theory, continental philosophy, cultural and media studies. He is author of the forthcoming *Posthumanism: A Critical Analysis* (Bloomsbury 2013). He is also a translator of cultural theory/philosophy from French into English (Derrida, Cixous, Stiegler).

**Arleen IONESCU** is Reader in English Literature and Critical Theory at University of Ploieşti, Romania and Vice-Dean of the Faculty of Letters and Sciences. She has published widely on Joyce and other related aspects of modernism, as well as on Beckett, Chaucer and Shakespeare. She is the author of *Concordanţe româno-britanice* (2004) and of *A History of English Literature. The Middle Ages and the Renaissance*, (2008, part of it revised for *A Short History of English Literature. The Middle Ages and the Renaissance*, 2012). She is currently working on Blanchot, Cioran, Beckett and Libeskind, as well as on the notion of hospitality in relation to issues of translation.

Gloria LAURI-LUCENTE is Associate Professor and Head of the Department of Italian at the University of Malta, where she teaches courses in Italian Literature, Anglo-Italian Studies, Comparative Literature and Film Studies. She is also Director of the Institute of Anglo-Italian Studies and Deputy Dean of the Faculty of Arts. She is the author of numerous papers and book chapters on the lyric tradition, Anglo-Italian Studies, and Film. Together with Francesco Marroni, she has co-edited *Jane Austen's* Emma: Revisitations and Critical Contexts (Aracne, 2011). She has also co-edited with Ivan Callus and James Corby Style in Theory: Between Literature and Philosophy (Bloomsbury Academic, 2013). She is currently completing 'Mutatas Formas': Posthumanism and Transembodiment in Ovid, Dante, and Petrarch, which is forthcoming from Rodopi and is also researching a book on literary and cinematic representations of organized crime in Italy and the United States.

Laura MARIN is Lecturer within The Department of Foreign Languages and Communication of the Technical University of Constructions Bucharest and Associated Lecturer at The Centre of Excellence for the Study of Image, University of Bucharest/University of Architecture and Urbanism "Ion Mincu". She holds a PhD from both Université Paris 7 and University of Bucharest in « La manière et les effets du neutre. Lire Blanchot dans les traces de Levinas et Derrida », forthcoming as a monograph at Editura Universității din București. Her research interests are in the field of theory of criticism, literature, the theory and practice of the image, with a special emphasis on Blanchot, Barthes, Derrida, Louis-René des Forêts, Henri Michaux, Georges Didi-Huberman. She is member of the editorial board of « Espace Maurice Blanchot », (www.blanchot.fr) and she published numerous articles on Blanchot in Studia Phaenomenologica, Euresis, Texte, Travaux en cours, Neutral, De la fictiv la real. Imaginea, imaginarul, imagologia (Editura Universității din Iași, 2010).

Francesco MARRONI is Professor of English at the G. d'Annunzio University of Chieti-Pescara. He is editor-in-chief of the following academic journals: *Merope*, *Rivista di Studi Vittoriani*, and *Traduttologia*. He is also director of C.U.S.V.E. (Centre for Victorian and Edwardian Studies – Pescara, Italy) and Vice President of the Gaskell Society (UK). His publications include monographs and articles mainly on Victorian literature. His most recent books are: *Spettri senza nome: modelli epistemici e narrativa vittoriana* (Carocci, 2007), *Victorian Disharmonies: A Reconsideration of Nineteenth-Century English Fiction* (University of Delaware Press, 2010) and *Come leggere 'Jane Eyre'* (Solfanelli, 2013). He has translated narrative works by Washington Irving, Elizabeth Gaskell, George Gissing, G. B. Shaw, etc. He is editor of the Victorian and Edwardian Studies Series for Peter Lang Verlag (Bern, Berlin and New York). As writer of fiction, he has authored six collections of short stories.

**Peter MAYO** is Professor in the Department of Education Studies, Faculty of Education, University of Malta. He specialises in Sociology of Education and Adult Education. His earlier work included *Gramsci, Freire and Adult Education* (Zed Books, 1999) subsequently published in six languages, and *Liberating Praxis* (Praeger, 2004; Sense, 2009). His most recent books include *Learning with Adults. A Critical Pedagogical Introduction* (with Leona English, Sense, 2012), *Politics of Indignation* (Zero Books, 2012) and *Echoes from Freire for a Critically Engaged Pedagogy* (Bloomsbury, 2013). He is editor of the book series International Issues in Adult

Education (Sense) and co-edits the series 'Postcolonial Issues in Education' (Palgrave-Macmillan). He co-edits the journal *Postcolonial Directions in Education*. Apart from publishing numerous articles in refereed journals such as *British Journal of Sociology of Education, Comparative Education, Critica Marxista, Cultural Studies Critical Methodologies* and *Das Argument*, he is a frequent contributor to *Truthout* and *Counterpunch*.

**Ionela NEAGU** is Reader in English Linguistics at University of Ploieşti where she teaches English syntax, morphology and pragmatics. Her publications focus upon political discourse analysis, conceptual metaphor theory, argumentation, and ELT Methodology. She is author of *Language Education Policies in Romania* (Romanian edition, University of Ploieşti Press, 2008), *English Syntax. Basic Concepts: the Syntax of the Simple Sentence* (University of Ploieşti Press, 2009), and *Decoding Political Discourse. Conceptual Metaphors and Argumentation* (Palgrave Macmillan, 2013).

Adina Oana NICOLAE is currently Lecturer in the Philology Department at University of Ploieşti, Romania. She teaches English phonetics and phonology as well as lexical semantics to philology students. Her research interests include cognitive linguistics, stylistics, CALL and ELT. In 2006 she published A Practical Guide to English Phonetics and Phonology and in 2011 English Phonetics and Phonology: A Primer. Her PhD thesis, defended at the West University, Timişoara, focuses on cognitive metaphors in the business and economics discourse. She has published over thirty articles on the dynamics of metaphor in present-day English and Romanian, on the translation of metaphors and on teaching ESP.

Vladimir TISMĂNEANU is Professor of Comparative Politics, at the University of Maryland. His research interests include forms of political participation, democracy building, the dynamics of political parties in East-Central Europe, and the theoretical foundations of civil society. **Gabriela VASILESCU** is Reader in the Philology Department at University of Ploiești (UPG). She teaches Aesthetics, Philosophy, and Communication. She holds a doctoral degree in Philosophy of Culture and Axiology (at University of Bucharest). Her research interests include aesthetics and philosophy of art, philosophy of culture, history of philosophy, and philosophy of communication. She has published essays on modernism and fashion and is currently working on an article on Surrealism. She is the founder of the Welsh Network of Modernist Studies, a postgraduate representative for the British Association of Modernist Studies, and was the principal organizer of the May 2013 Alternative Modernisms Conference at Cardiff University.

Geoffrey C. WILLIAMS is Professor of Linguistics at Université Bretagne-Sud (France), where he researches in the area of Corpus Linguistics and Lexicography.
